Deadline date for entries is Feb 10th .

Eligibility	Open to all USATT and ITTF members. Non-members may purchase a membership at the tournament, see fee schedule below. Most current USATT ratings will be used to determine eligibility. Un-rated players who win their round robin will not be eligible for awards. Their record will be used to determine their future rating. The winner of a round robin MUST be a rated player. The tournament committee reserves the right to limit eligibility in all events! If you're in need of a partner for the doubles event, the tournament committee will try to match you up with someone.
